Sub :-Regarding Permission for stamping/ stickering on containers, labels or wrappers of drugs manufactured and marketed by companies under Rule 104-A of Drugs & Cosmetics Rules, 1945

It has come to the notice of this organization that drugs meant for govt. supply /institutional supply/hospital supply etc. are being supplied by many firms to various government institutions without the inscription / make of "Govt. Supply"/institutional supply etc. In the absence of such on inscription, there is a possibility of pilferage & misuse of the drug. In such cases, it is imperative that drugs be supplied in the state with proper inscription, for which You are directed to take permission for stamping/stickering (Govt. Supply/institutional supply/Hospital supply/ 'Not for sale', each.) on containers, labels or wrappers of drugs manufactured and marketed by companies under Rule 104-A of Drugs & Cosmetics Rules, 1945 as per the requirement subject to following conditions :-

1. The permission will be applicable for the license address only.
2. The firm will have to maintain the record regarding each such stamping activities.
3. The firm will have to intimate to this office before and after such stamping activities product wise with batch numbers.
4. The firm will not be permitted to make any alteration of changes in the existing pre-printed matter.
5. The firm will have to carry out all the activities under the direct supervision of approved competent person of the firm.
6. The permission will be valid for the period of licenses and the authority will reserve the right to withdraw the permission so granted in case of any deviation. The permission will be applicable for supply of drugs Rajasthan state only.

Action shall be taken against those found carrying out the activity of stamping /stickering on drugs without permission of the undersigned.
