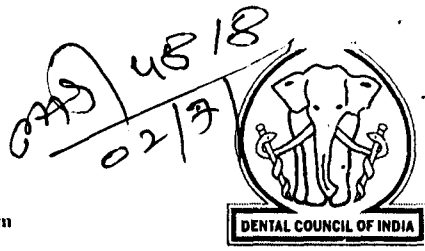

Sub: Admission in MDS Courses (both under Govt. & Management Quotas) during 2009-2010

I am directed to say that, earlier, it came to the notice of the Council that during 2008-2009 some of the dental colleges made excess admissions in MDS Courses over and above their annual sanctioned intake capacity **speciality-wise** and, consequently the Council was constrained to recommend to the Central Government to reduce the admission capacity in the concerned dental colleges to setoff the effect of the excess admissions in terms of the order passed by the Hon'ble Supreme Court of India on 12.1.2005 in WP No.306/2004 - Mridul Dhar & Anr. Vs. UOI & Ors.

In view of the above, I am directed to request that it may kindly be ensured that no excess admissions speciality-wise in MDS Courses are made and admissions are done as per criteria prescribed by your State Government. In case, it comes to the notice of the Council that excess admissions as per the sanction of GOI speciality-wise have been made in MDS Courses during 2009-2010 by the concerned dental colleges, a serious view would be taken and necessary steps would be initiated to set in motion the process of stoppage of admission and de-recognition of such dental colleges with requisite recommendations would be sent to the Central Government accordingly.

It may also please be noted that the Central Government has made it clear that it will not apply the neutralization formula in respect of excess admissions made, if any, in future and that where such instances are noticed despite the warning, the dental qualification in respect of such dental colleges would be recommended to the Central Government for de-recognised.

In view of above, you are requested to furnish an Undertaking to DCI immediately indicating that no excess admissions have been made in MDS Courses during 2009-2010 over and above the sanctioned intake capacity **speciality-wise** of your college.

It may also kindly be ensured that no admission beyond the approved capacity in each category of admission takes place in any dental college from the current academic session i.e. 2009-2010. If your dental college has any doubt about its admission capacity the same may please be referred to your concerned State Government for clarification under intimation to DCI and the Central Government.

In this connection, you are also directed that a list and under taking indicating the names of students admitted to MDS Courses during 2009-10 vis-à-vis the sanctioned and intake capacity may please be sent to DCI so as to reach us positively by 30.6.2009 in the following format. The copy of such list may also please be sent to the concerned university to which your college is affiliated with the request to certify the same and send to DCI quoting DCI's this letter number and date. The college authorities should follow up with the concerned university also till such time the list duly certified by the University is sent to DCI so as to reach us by 30.6.2009. In case a verified list is not sent by university to DCI 30.6.2009 as stipulated in DCI's Regulations called - "Criteria for Identification of Students admitted in excess of admission capacity of dental college Regulations 1998" - the admission in your college for the academic year 2010-2011 is liable to be stopped.

The list sent by the college may be verified by a Council Inspector.


