In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Revised Pay) Rules 2008 namely:-

1. These rules may be called the Rajasthan Civil Services (Revised Pay) (Tenth Amendment) Rules, 2010.
2. They shall come into force with immediate effect.
3. In the Rajasthan Civil Services (Revised Pay) Rules, 2008 – (i) **In Circuit Houses** – the existing entries appearing at S.No. 2, 3 and 4 under heading "(ii) Other posts" shall be substituted by the following, namely:-
