The PG Diploma in Public Health Management (PGDPHM) is supported by Ministry of Health and Family Welfare under National Rural Health Mission (NRHM) being run by all India Institute of Hygiene and Public Health (AIIH & PH), IIPH centers at ahmedabad, Delhi.
