SUB: PROPOSED CASUAL LEAVE AND MASS RESIGNATION OF DOCTORS (.)

THE STATE GOVERNMENT IS OF THE CONSIDERED VIEW THAT THE PROPOSED MASS CASUAL LEAVE ON 12-13<sup>TH</sup> JULY, 2011 AND MASS RESIGNATION ON 14<sup>TH</sup> JULY, 2011 IN THE STATE BY DOCTORS OF THE MEDICAL & HEALTH DEPARTMENT ON THE ISSUE OF PROMOTIONS AND OTHER SERVICE CONDITIONS IS LIKELY TO CAUSE DEEP DISRUPTION OF HEATH CARE FACILITIES IN THE SOCIETY THEREBY LEADING TO CRISIS SITUATION (.) THE STATE GOVERNMENT HAS THEREFORE DECIDED TO PREVENT AVAILING OF CASUAL LEAVE ON 12-13 JULY, 2011 AND ACCEPTANCE OF MASS RESIGNATION ON 14<sup>TH</sup> JULY, 2011 IN THE STATE. ORDERS ARE BEING ISSUED BY COMPETENT AUTHORITY TO DECLARE ANY SUCH LEAVE AND RESIGNATION ILLEGAL (.)

YOU ARE REQUESTED TO TAKE THE FOLLOWING STEPS IN PURSUANCE OF THIS DECISION:

1. ALL DOCTORS SHOULD BE ADVISED THAT TAKING OF CASUAL LEAVE ON 12-13<sup>TH</sup> JULY, 2011 AND MASS RESIGNATION ON 14<sup>TH</sup> JULY, 2011 WILL BE ILLEGAL AND MAKE THEM LIABLE FOR CRIMINAL ACTION (.)
2. ANY DOCTOR/MEDICAL STAFF WHO IS FOUND OR SUSPECTED TO BE INCITING OTHER DOCTORS/MEDICAL STAFF TO TAKE CASUAL LEAVE ON 12-13<sup>TH</sup> JULY, 2011 AND MASS RESIGNATION ON 14<sup>TH</sup> JULY, 2011 MAY BE TAKEN INTO CUSTODY IF SUCH A NEED ARISES (.)
3. DOCTOR/MEDICAL STAFF MAY BE PREVENTED FROM ORGANIZING MEETING/RALLIES FOR INCITEMENT IN THIS REGARD (.)
4. SMOOTH FUNCTIONING OF ALL MEDICAL AND HEALTH FACILITIES SHOULD BE CONTINUED AND NO DISRUPTION IN THIS REGARD SHOULD BE ALLOWED (.)
5. SEPARATE INSTRUCTIONS HAVE BEEN ISSUED FOR IMPLEMENTATION OF CONTINGENCY PLAN FOR CONTINUITY OF EMERGENCY MEDICAL SERVICES SUCH THAT PEOPLE AT LARGE ARE NOT PUT TO TROUBLE (.) PLEASE ENSURE STRICT COMPLIANCE OF THESE INSTRUCTIONS (.)
