Subject: Temporary deputation to CGI, Jeddah (Saudi Arabia for Haj-2025).

Sir,

l am directed to inform that 05 Doctors and 12 Paramedics (<u>list attached</u>) from Rajasthan have been selected for temporary deputation to CGI, Jeddah, Kingdom of Saudi Arabia for Haj 2025 by Ministry of Health and Family Welfare (MOH&FW) vide D.O. letter no. Z.32020/03/2023-SAS-II(EMR) dated 16.01.2025. The selection of the Doctors/Paramedics is subject to fulfilling of requisite criteria as laid down in MoH&FW's D.O. letter dated 16.01.2025 and submission of requisite documents namely:-

- i. Relieving order from the parent department.
- Last Pay Certificate (LPC) issued by your department/office indicating last pay drawn and deductions thereon (Pay slip will not be accepted in place of Last Pay Certificate).
- iii. Fresh Medical Certificate indicating physical fitness (as per copy enclosed).
- iv. Certificate of vaccination for meningitis/cerebral fever/polio/cerebrospinal meningitis/a dose of tetra vaccine (AC YW 135)/ inoculation for seasonal influence/influenza A (H1N1).
- 2. The Doctors/Paramedics is/are entitled only eight days preparation time for outward journey. You are requested to relieve concerned Doctor/Paramedics from your State/Hospital/Organization to report Haj Division, MOMA on 21st April 2025 so that he/she/they can complete requisite formalities well in time and attend the orientation training program and other formalities.
- 3. During the period of deputation to Jeddah, the Doctors/Paramedics is/are entitled to the following:
 - i. Basic Pay.
 - Foreign Allowance as admissible by CGI, Jeddah.

- iii. Free accommodation at Jeddah, Makkah, Madinah and Arafat as per deployment.
- iv. Air ticket from Delhi to Jeddah shall be provided by MoMA while return ticket shall be provided by CGI, Jeddah. No additional Baggage will be allowed apart from the baggage permitted by respective airlines.
- v. No Daily Allowance will be admissible for halts en-route and during movement between Jeddah/Makkah/Madinah (Saudi Arabia) while on official duty.
- vi. During 8 days preparation time, Doctor(s)/Paramedic(s) will be entitled for usual basic pay plus allowances as admissible in India.
- vii. No conveyance and D.A. claim will be admissible for journeys performed in India for completion of formalities related to deputation.
- viii. On completion of deputation and relieving from CGI, Jeddah, the Doctors/Paramedics stands reverted to parent office, salary and other usual allowances for transit period will be borne by Official parent Office/ Department.
- ix. Travelling expenditure from the place of posting to Delhi on onward journey by entitled class will be borne by CGI Jeddah. Return TA Bill will be settled in parent department.
- 4. Political Clearance has been obtained from MEA and the same has been sent to concerned RPOs.
- 5. Doctors/Paramedics is/are advised to apply online for official passport (https://www.passportindia.gov.in) and to contact the nearest Regional Passport Office to obtain Official Passport and submit the same to Haj Division, Ministry of Minority Affairs along with four colour photographs with white background and duly filled Visa form (copy enclosed).
- 6. It is, therefore requested to relieve the Doctor(s)/Paramedic(s) to report to Haj Division, MoMA at aforesaid address on 21st April, 2025 positively failing which their candidature will be cancelled without any proper correspondence and available candidate from waiting list will be selected as the Doctor(s)/Paramedic(s). The exact venue for reporting shall be communicated through deputation portal in due course.
