
**Subject: Amendment in the guidelines and specifications for the GPS to be attached with ultrasound sonography machine.**

Ref.: Letter No. 2659 dated 22.09.2015

With reference to the above cited subject and letter, following amendments and clarifications are hereby issued:


Reference	Amendment/ Clarification
Roles and Responsibilities:- <b>Page No. 1, Point No. (A), Sub Point 4</b> - "To provide the details viz website address, user-id, password and user-manual for the tracing/ online monitoring of USG machine to the concerned SDAA/ DAA/ CM&HO cum DNO (PCPNDT), District PCPNDT Coordinator, SAA and Sonography Center Owner." <b>and Sub Point 5</b> - "To keep the website functional 24 x 7 for anytime anywhere access, for the tracing/ online monitoring of USG machine by the concerned SDAA/ DAA/ CM&HO cum DNO (PCPNDT), District PCPNDT Coordinator and SAA."	It should be read as Roles and Responsibilities of GPS Service Provider: <b>Point No. (G) – GPS Service Provider, Sub Point 1</b> -"To provide the details viz website address, user-id, password and user-manual for the tracing/ online monitoring of USG machine to the concerned SDAA/ DAA/ CM&HO cum DNO (PCPNDT), District PCPNDT Coordinator, SAA and Sonography Center Owner." <b>and Sub Point 2</b> - "To keep the website functional 24 x 7 for anytime anywhere access, for the tracing/ online monitoring of USG machine by the concerned SDAA/ DAA/ CM&HO cum DNO (PCPNDT), District PCPNDT Coordinator and SAA" due to this henceforth the Point No. (A). Sub Point 6 & Sub Point 7 would be read as Point No. (A), Sub Point 4 & Sub Point 5 and Point No. (A). Sub Point 6 would be defined as "In case, GPS provider is not performing his duty then they will be under responsibility to do the same."
Procedure to be followed for GPS to be attached with the ultrasound sonography machines:- <b>Page No. 5, Point No. 5</b> - "Manufacturer / Authorized Distributor/ Authorized Dealer shall ensure to attach the GPS (also to mark UNIQUE S.No. other then IMEI No.) with USG Machine at their warehouse."	It should be read as "The Manufacturer/ Authorized Distributor/ Authorized Dealer shall not deliver USG machines without ensuring the delivery of GPS (to be fitted) on that machine. Both shall be installed at the same time at the registered sonography center. Without installing GPS any sale of machine shall amount to contempt of court's order."
