The Executive Engineer, RHSDP will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
- 4. Bids must be accompanied by security of the amount specified for the work in the table below, drawn in favour of **Project Director**, **RHSDP**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
- 5. Bids must be delivered to office respective Executive Engineer, M&H on or before 15.00 hours on the specified date as mentioned in the table and will be opened on the same dates at 15.30 hours in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bid will be received and opened on the next working day at the same time and venue.
