- 6. The technical bids of bidders who submit the bid security, bid fee & processing fee as per sl. No. 5 above will be opened on **14.10.2013** at 3.0 pm.
- 7. The bidders who qualify in technical bids will be intimated by e-mail regarding date & time of submission c. financial bids in the second stage of the bidding.
- 8. The bid shall be valid for a period of 120 days from the opening of the technical bid. If the bidder withdraws his offer/ alters any condition or rate during such period, than his bid security shall be forfeited.
- 9. The complete details regarding eligibility conditions, concept drawings, specifications, locations of work and terms conditions etc are available in the bid document.
- 10.One of the criteria for prequalification of bidders is construction & completion of one sample prefabricated sub centre on allotted site as per departments concept drawing and terms conditions. This sample shall be evaluated by a technical committee. PROSPECTIVE BIDDERS MAY APPLY FOR SAMPLE CONSTRUCTION ANY TIME AFTER PUBLICATION OF NIB, UPTO THE LAST DATE OF SUBMISSION OF BID. The sample shall have to be completed in a maximum period of 45 days. Payment shall be made only for samples approved by the technical committee at the rate of L1 bidder.
