- 10. The firm will repair the Equipments at Central Store, Sethi Colony, Jaipur and restore it to normal by carrying out repairs and replacements if necessary and re-install it in **Guarantee period**.
- 11. Equipment List placed at Annexure-5 (Defibrillator) and Annexure-6 (Ventilator)

#### **General Terms and Conditions**

- 1. The bid should not be conditional.
- 2. The firm will repair the Equipments at Central Store, Sethi Colony, Jaipur and restore it to normal by carrying out fulfill shortfall items, repairs, replacements and re-install if necessary.
- 3. The Equipments for repair may be inspected on any working day from 10 AM to 1 PM from 10 AM, prior intimation to PD, NHM; List of Equipments is placed at Annexure-5 (for Defibrillator) and Annexure-6 (for Ventilator).
- 4. Rates for shortfall items, repair, replacement of part and re-install of each equipment are to be quoted as per complete bunch of Defibrillator (Annexure-5) and Ventilator (Annexure-6) separately.
- 5. <u>L-1 shall be decided for either rate for complete bunch of Defibrillator (Annexure-5) and Ventilator (Annexure-6) separately with CMC rates for three years or without CMC rates for three years.</u>
- 6. Preference will be given to authorized service provider of the equipment in case of joint L1.
- 7. The rates quoted should be inclusive of shortfall items, repair charges, charges for replacement of defective parts, calibration, re-installation of unit, transportation charges & visiting charges, inclusive of all type of Taxes.
- 9. Bidder should have at least **03 years** of experience repair of same/similar equipment in a Central/State Govt. hospital/Private Sector. Repair orders issued from appropriate authority should be attached.
- 10. Authority letter from manufacturer/authorized service provider certificate is to be provided in case the bid is submitted by authorized agent.
- 11. After repairs, machine should be made fully functional otherwise no payment in respect of repair, replaced, shortfall parts or otherwise shall be made. All defective/replaced parts shall be handed over to Department after repair.
- 12. After repair, machine / equipment shall be kept under the observation for a period of at least two weeks at the re-installed place.
- 13. The bidder shall be responsible for all repairs during observation period and no payment in this regard shall be made.
- 14. The spare parts or shortfall items which required as replacement or newly fixed items should be original/compatible with the equipment and of standard quality.
- 15. If there is a resultant damage of part in the equipment due to faulty repair work or use of inferior quality spares by the successful bidder, there will no payment against that repair and earnest money may be forfeited.
- 16. After repair/replacement or fulfillment of shortfall items, a certificate to the effect that the equipment is in working order and safe for patient care and non- hazardous for the handlers shall be submitted by the firm.
- 17. Firm has to provide guarantee on newly fixed, replaced or repaired spare for at least 6 (six) months.
- 18. Photocopy of service Tax NO and PAN NO should also be enclosed with the technical bid documents.
- 19. The work order should be executed by the successful bidder within Fifteen days from the date of receiving the same.
- 20. In Guarantee period, each and every complaint /call will be attended within 24 hours, In case any equipment break-down time for more than 120 hours/5 days for want of visit by the bidder, penalty may be charges Rupees five Hundred per day (Varies from equipment to equipment). The complaint may be sent to firm by way of telephone/fax/letter or e-mail. The amount of L.D. will be directly deducted from the E.D. of the firm at the time of refund or before by way of any adjustment order.
- 21. After repair, units shall be re-installing at indicative places in Rajasthan (as per Annexure-8). After re-install, satisfactory work performance certificate shall be issue from the user department.
- 22. The bidding process shall be subject to the provisions of the Rajasthan Transparency in Public Procurement Act, 2012 and Rules, 2013 made there under.
- 23. If any dispute arises regarding this bid, such dispute shall be subject to settlement under Dispute resolution committee.
- 24. MD, NHM has right to cancel the tender without assigning any reason at any stage.
