All 9 proposals are examined by the bid evaluation committee.

The bid evaluation committee found shortcomings in following proposals:-

1. Raksha Health Insurance TPA pvt. Ltd.

- ➤ Registration certificate to certify that Raksha Health Insurance TPA pvt. Ltd. is a registered private or public owned company incorporated under The Companies Act, 1956 and/or 2013, in India is not found in the documents provided by said bidder.
- Document proving that bidder is registered with the IRDAI as TPA for at least, last three completed financial years is not found in the documents provided by said bidder.
- Document proving that said bidder has experience of handling at least 50,000 health claims during the last financial year is not conclusive.
- ➤ Certificate(s) from statutory auditors or Chartered accountant of the Applicant or the IRDA stating the number of families covered through health insurance policies during the past 3 (three) years is not provided by the said bidder.
- Document proving that said bidder has experience in processing medical claims of not less than Rs.200 crores in last financial year (Year 1 being the latest completed financial year, preceding the bidding) is not found in the documents provided by said bidder.

2. Paramount Health service & Insurance TPA pvt. Ltd.

➤ 1. Copies of the balance sheets, financial statements and Annual Reports for 3 (three) years preceding the application due date are not found in the documents provided by said bidder.

3. Good Health Insurance TPA Ltd.
