The gross salary as reported by the Service Provider per month for Pilot on 07.11.2019 was Rs.6377/- and gross salary per month of EMT was Rs.6587/- as per calculation based on 8 Hours shift working and Rs.9566/- and gross salary per month of Pilot and Rs.9880/- per month for EMT as per calculation based on 12 Hours shift working.	 a). The present gross salary per month for Pilot on 07.11.2019 was Rs.9566/- (In words Nine Thousand Five Hundred Sixty Six Only) and Rs.9880/- (in Words Nine Thousand Eight Hundred Eighty Only) per month for EMT. This calculation is based on 12 Hours shift working. The service provider is required to follow 8 /12 Hours working shift as per the laws. d). The escalation shall be provided @ 3% per year.
